WASHINGTON, D.C.— January 29, 2002, Congressional and White House sources told CNN that "President Bush personally asked Senate Majority Leader Tom Daschle Tuesday to limit the Congressional investigation into the events of September." The January 29 call from the president was followed by "a rare call to Daschle from Vice President Dick Cheney last Friday to make the same request," CNN reported in the same story.

"The vice president expressed the concern that a review of what happened on September 11 would take resources and personnel away from the effort in the war on terrorism," Daschle told reporters January 29, 2002. Though Daschle stated at the time that he did not agree to limit the scope of the investigation.

The Kean-Hamilton (9/11) Commission, convened over 400 days after the events of 9/11, produced no persons responsible for the tragic 9/11 attacks.


Whitewash As Public Service



Vermont towns approve Bush – and Cheney - “indictment”

In Brattleboro, Vermont, Voters there approved measures calling for the indictment of Bush and Cheney and accused both of violating the Constitution.

March 4, 2008 The measures carry no legal weight and are more symbolic than anything. They call on police to arrest Bush and Cheney if they ever visit Brattleboro or nearby Marlboro.

In Brattleboro, the vote was 2,012 to 1,795. In Marlboro, which held a town meeting on the issue, it was 43-25 with three abstentions.

“Voters interviewed after casting ballots in Brattleboro said they saw the article as an opportunity to express their frustration over the war in Iraq and Bush’s tenure in general.”

AP says “The White House press office isn’t commenting, but the Republican National Committee denounced the indictment effort.”

Senate candidate calls for Bush’s arrest

KENNEBUNKPORT — Calling President George Bush “the worst president in the history of the United States,” Independent U.S. Senate candidate Laurie Dobson stood on the steps of Town Hall Tuesday and called upon the town to indict Bush and Vice President Dick Cheney as war criminals.

Saying that both had “made killing fields of many countries,” Dobson urged town leaders to issue a warrant for their arrests.

“There is compelling, undeniable, irrefutable evidence that crimes are going on,” she said.

Dobson filed a copy of her indictment with Town Manager Larry Mead. Flanked by campaign manager Bruce Marshall and human rights lawyer Harold Burbank, Dobson said she will do what she can to gathering petitions, to see that the issue makes it on to the town warrant in June.

The central focus of Dobson’s campaign has been calling for an end to the war in Iraq and the impeachment of both Bush and Cheney. If impeachment doesn’t happen, though, she wants both to be indicted as war criminals and for “crimes against our Constitution.”

As for the indictment, Dobson said she was following in the footsteps of Brattleboro, Vt., who adopted an indictment resolution in that town.

Things weren’t looking quite as simple in Kennebunkport.

“Under Maine law, towns have no power to indict,” Mead said.

Further, though Dobson called upon the police to arrest both Bush and Cheney should they come to town, that doesn’t appear likely either.

Text of Laurie Dobson’s call for indictment:

“Shall the Kennebunkport Board of Selectmen instruct the Town Attorney to draft indictments against President Bush and Vice President Cheney for crimes against our Constitution, and publish said indictments for consideration by other authorities, and shall it be the law of the Town of Kennebunkport that the Kennebunkport Police, pursuant to the above-mentioned indictments, arrest and detain George W. Bush and Richard Cheney in Kennebunkport if they are not duly impeached, and prosecute or extradite them to other authorities that may reasonably content to prosecute them.”

U.S. Military Wanted to Provoke War With Cuba

Book: U.S. Military Drafted Plans to Terrorize U.S. Cities to Provoke War With Cuba By David Ruppe

N E W Y O R K, May 1, 2001 - In the early 1960s, America’s top military leaders reportedly drafted plans to kill innocent people and commit acts of terrorism in U.S. cities to create public support for a war against Cuba.

Code named Operation Northwoods, the plans reportedly included the possible assassination of Cuban émigrés, sinking boats of Cuban refugees on the high seas, hijacking planes, blowing up a U.S. ship, and even orchestrating violent terrorism in U.S. cities.

The plans were developed as ways to trick the American public and the international community into supporting a war to oust Cuba’s then new leader, communist Fidel Castro.

America’s top military brass even contemplated causing U.S. military casualties, writing: “We could blow up a U.S. ship in Guantanamo Bay and blame Cuba,” and, “casualty lists in U.S. newspapers would cause a helpful wave of national indignation.”

In Marlboro, Bush-Cheney indictment passes in non-binding floor vote

MARLBORO, Vt. beat Brattleboro to the punch in calling for the indictment of President Bush and Vice President Cheney.

In a non-binding floor vote, residents of the southern Vermont town of 978 people approved an article that calls for Bush and Cheney to be arrested for crimes against the Constitution.

The vote was 43 for, 25 against and three abstentions.

I, said O’Connor, am against judicial reforms driven by nakedly partisan reasoning. A prominent federal judge has told a conference of liberal lawyers that Dictator Bush’s rise to power was similar to the accession of dictators such as Mussolini and Hitler. **“In a way that occurred before but is rare in the United States... somebody came to power as a result of the illegitimate acts of a legitimate institution that had the right to put somebody in power.**

That is what the Supreme Court did in Bush versus Gore. It put somebody in power,” said Guido Calabresi, a judge on the 2nd Circuit Court of Appeals, which sits in Manhattan. **“The reason I emphasize that is because that is exactly what happened when Mussolini was put in by the king of Italy,”** Judge Calabresi continued, as the allusion drew audible gasps from some in the luncheon crowd Saturday at the annual convention of the American Constitution Society.

This would give him absolute dictatorial power over the government with no checks and balances.

book by investigative reporter James Bamford about the history of America’s largest spy agency, the National Security Agency. However, the plans were not connected to the agency, he notes.

The plans had the written approval of all of the Joint Chiefs of Staff and were presented to President Kennedy’s defense secretary, Robert McNamara, in March 1962. But they apparently were rejected by the civilian leadership and have gone undisclosed for nearly 40 years.

“These were Joint Chiefs of Staff documents. The reason these were held secret for so long is the Joint Chiefs never wanted to give these up because they were so embarrassing,” Bamford told ABCNEWS.com. “The whole point of a democracy is to have leaders responding to the public will, and here this is the complete reverse, the military trying to trick the American people into a war that they want but that nobody else wants.”

The documents show “the Joint Chiefs of Staff drew up and approved plans for what may be the most corrupt plan ever created by the U.S. government,” writes Bamford.

Crime scene scrubbed

This photo was taken at Ground Zero shortly after the smoke cleared. The most dramatic column pictured here is centered for us. The 60-degree angle cut is indicative of shaped charges placed by demolitions experts. At the low end of the cut column is some hardened molten metal. The temperatures necessary to melt steel are significantly greater than the temperature of burning jet fuel or any other burning material in these buildings. The best "guess" as to what material could have been used in these shaped charges is thermite, which burns at temperatures great enough to melt steel.

Forensic fire investigators would have been able to determine conclusively how these columns were cut. An investigation could have followed many other leads as well and a final, public report would have supported or contradicted the government's "pancake collapse" theory that jet fuel-induced fires weakened upper floors, which collapsed like pancakes on top of one another.

But an investigation was never conducted. Fire investigators were, in fact, prevented from investigating the crime scene and rubble removal began almost immediately by order of Mayor Guiliani.

On January 4, 2004, *Fire Engineering* magazine Editor-in-Chief Bill Manning called for fire professionals across the nation to demand removal of the rubble be stopped immediately and a thorough investigation of the Twin Towers' collapses get underway. In his "Call to Action," Manning wrote, "Selling the Investigation." He listed all the reasons why and noted the obvious: No one should be allowed to haul evidence away from a crime scene until it has been thoroughly investigated.

Manning's qualified assessment of the government's investigation into the collapse of the Twin Towers is quoted below:

"*Fire Engineering has reason to believe the official investigation, blessed by FEMA and run by the American Society of Civil Engineers, is a half-baked farce that may already have been commandeered by political forces whose primary interests, to put it mildly, lie far afield of full disclosure.*"

Fire Engineers Call WTC Probe 'Half-Baked Farce'

A respected professional magazine read by firefighters and engineers is calling the investigation into the collapse of the World Trade Towers a farce and a sham. Exclusive to American Free Press - Jan. 21, 2002 By Christopher Bollyn *Fire Engineering* magazine, the 125-year old journal of record among America's fire engineers and firefighters, recently blasted the investigation being conducted by the Federal Emergency Management Agency (FEMA) of the collapsed World Trade Center as a "half-baked farce."

Fire Engineering's editor, William Manning, issued a "call to action" to America's firefighters and fire engineers in the January issue asking them to contact their representatives in Congress and officials in Washington to demand a blue ribbon panel to thoroughly investigate the collapse of the World Trade Center structures.

Fire Engineering frequently publishes technical studies of major fires and is read in more than 50,000 fire departments and schools of fire engineering across the nation.

Manning challenged the theory that the towers collapsed as a result of the crashed airliners and the subsequent fuel fires, saying, "Respected members of the fire protection engineering community are beginning to raise red flags, and a resonating theory has emerged: The structural damage from the planes and the explosive ignition of jet fuel in themselves were not enough to bring down the towers."

No evidence has been produced to support the theory that the burning jet fuel and secondary fires "attacking the questionably fireproofed lightweight trusses and load-bearing columns directly caused the collapses," Manning wrote, adding that the collapses occurred "in an alarmingly short time."

Because no "real evidence" has been produced, the theory that the twin towers collapsed due to fire "could remain just unexplored theory," Manning said.

Manning visited the site shortly after the collapse and his photographs appeared in the October issue of *Fire Engineering*. None of the photos show the load-bearing central steel support columns standing or fallen, which raises the question, what caused these columns to disintegrate?

An eyewitness to the collapse told AFP that as he stood two blocks from the World Trade Center he had seen "a number of brief light sources being emitted from inside the building between floors 10 and 15." He saw about six of these brief flashes, accompanied by a "crackling sound" immediately before the tower collapsed.

DESTRUCTION OF EVIDENCE

The steel from the site must be preserved to allow investigators to determine what caused the collapse, Manning said. "The destruction and removal of evidence must stop immediately."

"For more than three months, structural steel from the World Trade Center has been and continues to be cut up and sold for scrap. Crucial evidence that could answer many questions about high-rise building design practices and performance under fire conditions is on the slow boat to China," Manning said, "perhaps never to be seen again in America until you buy your next car."

"Such destruction of evidence," Manning wrote, "shows the astounding ignorance of government officials to the value of a thorough, scientific investigation of the largest fire-induced collapse in world history."

Nowhere in the national standard for fire investigation does one find an exemption allowing the destruction of evidence for buildings over 10 stories tall, Manning said. "Clearly, there are burning questions that need answers. Based on the incident's magnitude alone, a full-throttle, fully-resourced, forensic investigation is imperative. The lessons about the buildings' design and behavior in this extraordinary event must be learned and applied in the real world.

The collapse of the World Trade Center was the first total collapse of a high-rise during a fire in United States history and the largest structural collapse in recorded history. The collapse resulted in the deaths of some 3,000 people, the second largest loss of life on American soil and the largest loss of firefighters ever at one incident, yet congressional hearings or a "blue ribbon" commission looking into the events of Sept. 11 have not been called for, and may never be.

Sheen said that most people's gut instinct that the buildings had been deliberately imploded, was washed away by the incessant flood of the official version of events from day one.

WTC 'INVESTIGATION'?

In a separate editorial, "WTC Investigation? A Call to Action," by the magazine's technical editor, Prof. Glenn Corbett of John Jay University in New York City, and two other expert fire engineers who specialize in high-rise buildings, the FEMA-led investigation was called "uncoordinated" and "superficial."

"The World Trade Center disaster demands the most comprehensive, detailed investigation possible," the writers said. "No event in our entire fire service history has ever come close to the magnitude of this incident."

Given the magnitude of the disaster "you would think we would have the largest fire investigation in world history," the editorial says. "You would be wrong. Instead, we have a series of unconnected and uncoordinated superficial inquiries. No comprehensive 'Presidential Blue Ribbon Commission.' No top-notch National Transportation Safety Board-like response. Ironically, we will probably gain more detailed information about the destruction of the planes than we will about the destruction of the towers. We are literally treating the steel removed from the site like garbage, not like crucial fire scene evidence."

RECYCLING THE EVIDENCE

On Christmas Day, *The New York Times* reported that structural engineers have demanded a completely new investigation because the decision to quickly recycle the tower's steel columns, beams and trusses had resulted in the wholesale destruction of critical evidence.

Dr. Frederick W. Mowrer, an associate professor in the fire protection engineering department at the University of Maryland, said the decision had compromised any investigation of the collapses.

"I find the speed with which potentially important evidence has been removed and recycled to be appalling," Mowrer said.

Officials in the New York mayor's office refused to reply to written and oral requests from *The New York Times* over a three-day period about who actually made the decision to recycle the steel, seriously handicapping the investigation.

The engineers said that the "serious mistake" to recycle the structural steel deprived investigators of the most important direct physical evidence required when trying to piece together what caused the towers to collapse. In the United States there are thousands of similar lightweight, center-core construction high-rise buildings with light-density, sprayed-on fireproofing, according to Manning.

"We have to learn from incidents through investigation to determine what types of codes should be in place and what are the best practices for high-rise construction," Manning told the *Daily News*. "The World Trade Center is not the only lightweight, core construction high-rise in the U.S. It's a typical method of construction."

ACCOUNTABILITY VACUUM

Engineers have also complained that they have been shackled with bureaucratic restrictions that prevented them from examining the disaster site, interviewing witnesses and requesting crucial information like recorded distress calls to the police and fire departments.

"This is almost the dream team of engineers in the country working on this, and our hands are tied," one engineer who asked not to be identified told the *Times*. Members of the team of engineers have been threatened with dismissal for speaking to the press.

"FEMA is controlling everything," the anonymous engineer complained.

"Comprehensive disaster investigations mean increased safety," Manning said. "They mean positive change. NASA knows it. The NTSB knows it. Does FEMA know it?"

"No. *Fire Engineering* has good reason to believe that the 'official investigation' blessed by FEMA and run by the American Society of Civil Engineers is a half-baked farce that may already have been commandeered by political forces whose primary interests, to put it mildly, lie far afield of full disclosure," he wrote.

An autopsy of a retired NYPD detective confirmed yesterday what his family and fellow cops long suspected - that James Zadroga's death was "directly related" to the Ground Zero cleanup.

The stunning findings are believed to mark the first time the death of a cleanup worker has been officially tied to the aftermath of the terror attacks.

"It is felt with a reasonable degree of medical certainty that the cause of death in this case was directly related to the 9/11 incident," Dr. Gerard

Breton, a pathologist at the Ocean County, N.J., medical examiner's office wrote in the Feb. 28 autopsy report.

Zadroga died on Jan. 5 of pulmonary disease and respiratory failure - and he had lung-tissue inflammation Breton attributed to "a history of exposure to toxic fumes and dust."

The autopsy report was released yesterday by Michael Palladino, president of the Detectives' Endowment Association, and Zadroga's grieving father, Joseph.

Windsor Dems Reprimand Lieberman

WINDSOR - Upset by U.S. Sen. Joseph I. Lieberman's unwavering support for the war in Iraq, the Democratic Town Committee has formally expressed its discontent. A resolution reprimanding Lieberman for his war stance passed 34-1 with two abstentions during a meeting Thursday. Democratic Town Chairman Timothy Fitzgerald said the Bush administration misled the nation into war. "They wanted the war from Day One," Fitzgerald said today, referring to the Bush administration.

"And they made sure that everything was presented in the most ominous way. Joe should have seen through that."

Fitzgerald said Lieberman should have amended his position on the war after it became clear many of the administration's justifications for it, including the presence of weapons of mass destruction, were not true.

International lawyers and anti-war campaigners reacted with astonishment yesterday after the influential Pentagon hawk Richard Perle conceded that the invasion of Iraq had been illegal.

In a startling break with the official White House and Downing Street lines, Mr Perle told an audience in London: "I think in this case international law stood in the way of doing the right thing."

President George Bush has consistently argued that the war was legal either because of existing UN security council resolutions on Iraq - also the British government's publicly stated view - or as an act of self-defence permitted by international law.

But Mr Perle, a key member of the defence policy board, which advises the US defence secretary, Donald Rumsfeld, said that "international law ... would have required us to leave Saddam Hussein alone", and this would have been morally unacceptable. mechanism consistent with the rules of the UN for dealing with Saddam Hussein".

Mr Perle, who was speaking at an event organised by the Institute of Contemporary Arts in London, had argued loudly for the toppling of the Iraqi dictator since the end of the 1991 Gulf war.

"They're just not interested in international law, are they?" said Linda Hugl,

a spokeswoman for the Campaign for Nuclear Disarmament, which launched a high court challenge to the war's legality last year.

"It's only when the law suits them that they want to use it."

Mr Perle's remarks bear little resemblance to official justifications for war, according to Rabinder Singh QC, who represented CND and also participated in Tuesday's event.

They have seen photos of Iraqi babies born with deformities that are eerily similar.

Another guardsman from New York, Herbert Reed, told at the U.N. on May 3, 2005, that he has serious physical debilities and suffers memory loss. No one in the military would give him a straight answer about the origin of the illnesses he suffered after returning from Iraq a couple of years ago - body aches, rashes, boils, joint aches and nerve damage.

Matthew believed that his illness and his daughter's deformity were caused by his exposure to depleted uranium (DU), a component used in tank armor and weapon shells. He asked the Army to test his urine for DU, but never got the test results. Finally Matthew and Reed sought help from the New York Daily News to arrange for independent urine testing for DU. **They both were tested positive for depleted uranium (DU).**

Matthew was tested and his exposure to Depleted Uranium has been confirmed.

DU is a radioactive, heavy metal denser than lead, which allows it to penetrate armor easily. Additionally, when DU hits a tank's metal armor, the heat of the impact can melt the armor and generate clouds of DU dust which can be inhaled or ingested by soldiers or civilians. **The DU particles lodged inside bodies become a nightmare for health hazard.**

The U.S. Armed Forces Radiobiology Research Institute has found that DU produced chromosome (genetic) damage and

caused delayed reproductive death (*J. Inorg. Biochem.* 2002, 91: 246-52 and *J. Environ. Radioact.* 2003, 64: 247-59). In 2002, **the United Nations Sub-Commission on the Promotion and Protection of Human Rights declared that DU was a weapon of mass destruction, and its use a breach of international law.**

Iraqi and visiting doctors, and a number of news reports, have reported that birth defects and cancers in Iraqi children have increased five- to 10-fold since the 1991 Gulf War and continue to increase sharply, to over 30-fold in some areas in southern Iraq. Currently, more than 50 percent of Iraqi cancer patients are children under the age of 5, up from 13 percent. Children are especially vulnerable because they tend to play in areas that are heavily polluted by depleted uranium.



The Pentagon has been using radioactive weapons for at least a decade and a half with full complicity of at least three White House administrations and Republican and Democratic congressional legislators. Conservatively, at least 300 tons and 1,700 tons of depleted uranium were used in the Gulf War and the current Iraq War, respectively. This is about 70 grams of depleted uranium per Iraqi citizen, and if inhaled or ingested, it is enough to kill them all.
